



Agreement & Terms & Conditions of Hire Plus - current as of July 2008

1. Instruments are hired to you by Silver Keys & Strings Music Centre & on signing this agreement you AGREE to the conditions on this schedule and acknowledge that the instrument is at all times the property of us.
2. You AGREE not to sell, assign, charge, part with or otherwise deal with the instrument during the hire term or any extension or holding over period.
3. You AGREE to notify us immediately in writing upon the instrument no longer being kept at the home address listed on the schedule.
4. You acknowledge that this hire agreement does NOT give you the right to purchase the instrument at the end of the hire term or any extension or holding over period.
5. We agree to maintain the instrument free of charge for normal wear and tear during the hire period. You are responsible for all other maintenance and repair work. All maintenance and repair work is to be carried out by Silver Keys & Strings. Instruments are not to be serviced or repaired elsewhere.
6. You are responsible for loss, negligence and damage of the instrument and we reserve the right to be indemnified from you for damages and costs and other related expenses.
7. The hire instrument is insured against fire and also theft by forced entry only at the home address of the hirer as shown on this form. An excess of \$250 applies to any claim. A Police Report No. is required.
8. Whilst every effort is made to maintain hire rates, we reserve the right to change the hire fee at any time.
9. The initial hire period is for two months and thereafter is payable monthly. The first two months are paid on collection of the instrument and thereafter charged to your credit card each month. If you do not wish to continue hiring you must return the instrument before your due date each month. **Instruments not returned BEFORE this date will have the next months hire fee charged to your credit card.**
10. **We agree to credit** 30% of the hire fee paid in the first 12 months off the purchase of a new instrument from us selected from our range in stock at the displayed special discount prices for Hire Plus customers. Examples of these products are given in our Instrument Hire Rate Brochure.
